WITHDRAWING PUBLIC LANDS FOR USE OF DEPARTMENT OF THE AIR FORCE FOR MILI-TARY PURPOSES

By virtue of the authority vested in the President, and pursuant to Executive Order No. 10355 of May 26, 1952, it is ordered as follows:

Subject to valid existing rights, the hereinafter-described public lands in Alaska, including the mineral resources thereof, are hereby withdrawn from all forms of appropriation under the publicland laws, including the mining but not the mineral-leasing laws, and the lands, excluding the mineral resources, are reserved for use of the Department of the Air Force for military purposes.
