Subject: Railroad right-of-way

On November 19, 1948, the Corps of Engineers forwarded prints of a map of a right-of-way across public lands for a railroad spur from Ladd Air Force Base to Eielson Air Force Base, Alaska, desired by the Department of the Air Force.

On February 7, 1950, this Office transmitted one of the prints to you with directions that notation of the spur line rightof-way be made upon the records, and that there be inserted in any final certificate which may be issued for the lands affected by the right-of-way, an exception clause similar to that quoted in the instructions of January 13, 1916 (44 L.D. 513).

On July 26, 1951, the Office of Territories forwarded evidence of the transfer of the title to the spur to The Alaska Railroad, and requested that the records be noted to show that the right-of-way extends to a width of 100 feet on each side of the central line of the track, being a <u>total width of 200 feet</u>. You will note your records to show the change of ownership and the width of the right-of-way.

MEMORANDUM for the Manager, District Land Office, Fairbanks, Alaska.

Reference is made to your memorandum dated January 16, 1947, relating to a letter sent by the War Department on January 13, 1947, to John I. Gilmore, P. O. Box 1980, Fairbanks, Alaska.

Gilmore made homestead entry Fairbanks 05992 for the N2NW4, SW4NW4 sec. 27, NE4NE4 sec. 28, T. 1 S., R. 1 E., F.M., Alaska, under Section 2289 R.S. on September 10, 1945. On August 29, 1946, Gilmore submitted final proof which is held suspended in this Bureau awaiting a field report.

The notice from the War Department to Gilmore reads:

In connection with the construction of certain additional improvements at Mile 26, Satellite Field, the War Department has approved an extension of the existing railroad spur line from Ladd Field.

This letter will notify you as claimant to Entry 05992 on record in the Bureau of Land Management, Department of the Interior, Fairbanks, Alaska, that spur line right of way will traverse the property on which you have filed following the northerly side of the Richardson Highway. Provision for reservation or creation of railroad right of ways constructed by the Government on public lands is contained in Act of Congress of March 12, 1914 (38 Stat., 305).

Construction will be performed to cause a minimum of interference with your normal use of the land in so far as practicable.

The Act of March 12, 1914, authorizing the President of the United States to locate, construct and operate railroads in Alaska, provides that:

Terminal and station grounds and rights of way through the lands of the United States in the Territory of Alaska are hereby granted for the construction of railroads, telegraph and telephone lines authorized by this Act, and in all patents for lands hereafter taken up, entered or located in the Territory of Alaska there shall be expressed that there is reserved to the United States a right of way for the construction of railroads, telegraph and telephone lines to the extent of one hundred_fest_on_either side of the center line of any such telegraph or telephone lines, and the President may, in such manner as he deems advisable, make reservation of such lands as are or may be useful for furnishing materials for construction and for stations, terminals, docks, and forsuch other purposes in connection with the construction and operation of such railroad lines as he may deem necessary and desirable.

In view of the provisions above referred to, included in the Act of March 12, 1914, it would appear that the War Department was within its statutory rights in so notifying Gilmore.

is no plat is on file in my office, I have not inserted in final certificates any reservation in accordance with 44 L.D. 513. However, this is not actually necessary, for all patents carry a notation that the lands are subject to the provisions of the Act of Congress of March 12, 1914, which provides:

"Terminal end station grounds and rights of may through the lands of the United States in the Territory of Alasha are hereby granted for the construction of . railroads, telegraph and telephone lines authorized by . this Act, and in all patents for lands hereafter taken up, sniered or located in the Territory of Alaska there shall be expressed that there is reserved to the United States a right of way for the construction of railroads, telegraph and tolephone lines to the extent of one hundred feet on the either side of the center line of any such telegraph or the telephone lines, and the President may, in such manner as he doens advisable, make reservation of such lands as are or may be useful for furnishing materials for construction and for stations, terminals, docks, and for such other purposes in connection with the construction and operation of such railroad lines as he may deem necessary and desirable."


I would appreciate receiving a copy of the map mentioned in order that I can complete my records here.

Dear Sir:

In connection with the construction of certain additional improvements at Mile 26 Satellite Field, the War Department has approved an extension of the existing railroad spur line from Ladd Field. It has been directed that construction he completed as quickly as possible in order that necessary construction materials for planned improvements at Mil2 26 may be hauled in by rail this spring to be used during the summer construction period.

All affected entrymen have been advised by this office by letter tha construction has been approved and that right of way will traverse their entries. Copies of letters have been provided the Register, District Land Office, Fairbanks, who in turn has transmitted letters to you. Action necessary to secure right of ways through patented areas under provisions of the Act of Congress of 12 March 1914 (38 Stat 305) is being held in abeyance pending receipt by this office of a surveyed traverse of the right of way referencing known section lines and corners. Upon receipt of such a survey a copy will be filed with your office in order that necessary approval of the right of way may be given by the Bureau of Land Management and easements created in patents covering tracts upon which final proof has been submitted. Entries and patented tracts effected prints of property map, Richardson Highway, Sheets 1 and 2.

Gilmore, Fairbanks Homestead Entry 05992. Similar letters were sent to the homestead entryman whose serial numbers follow/ 03098, 03704, 04131, 04361, 04827, 05279, 05670, 05700, 05721, 05769, 05821, 05874, 06169, and 06246.

Several homestead entrymen have appeared in my office and complained that work has already begun on the railroad extension and that the proposed route will seriously interfere with access to their homes and improvements. In one case it appears that the homestead entryman has been notified that it will be necessary to move his house.

No application for a railroad right of way has been filed in my office.
