REQUEST FOR SPECIAL USE PERMIT

Purpose of SUP: OASIS Environmental is in the process of conducting a Phase II
Site Assessment on Tax Lot 3504, Section 35, T1S, R1E, F.M. This assessment will focus on collecting 9 soil borings and placing 9 temporary groundwater monitoring locations 25 feet north of the Haines-Fairbanks pipeline that is in the Alaska Railroad right-of-way. OASIS has been told by the Ft. Wainwright Dept. of Public Works that the CANOL pipeline was adjacent to the Haines-Fairbanks line in this location. USACE provided OASIS with an original drawing of the CANOL pipeline placing it along the Old and New Richardson Highways in Section 35. The USACE has no other information regarding the status of the CANOL pipeline in this area. Most of the CANOL pipeline was placed on the surface of the ground but in a limited number of locations it was buried. No record remains of where the buried sections are located.

In an attempt to locate a possible buried section of the CANOL pipeline, OASIS plans to use ground penetrating radar in the area indicated by USACE along the highway. If a buried pipe cannot be located, no further action will occur. If buried pipe can be located, 8 soil borings will be collected and 8 temporary monitoring wells will be placed 10 feet to the east/northeast of the CANOL pipeline.

OASIS plans to conduct these activities as soon as we issue a Special Use Permit. The ground penetrating radar activities will consist of two people on a snowmachine pulling a sled with the GPR unit in the area where the CANOL pipeline ran. This activity will take approximately ¹/₂ day. If ground sampling were to occur, it would consist of a drill rig and crew of about 4 people working in the area for up to 4 days. Only about 25 percent of this time period would be within the ROW (+/- 1 day).

Location: Northeast side of the New Richardson Highway at approximately 354.5 Mile and the northeast side of the Old Richardson Highway east of Rivers Wood Products. If the work advances to drilling, the permit should require the company to provide actual locations of borings, a description of procedures and what facilities may be left in place for monitoring, and a description of measure taken to clean up drill cuttings, etc. If they will be working in the clear zone a traffic control plan should be required.

This area is within the project limits of Richardson Highway MP 353-357 Access Improvements project. If the permitted work will include borings and monitoring wells, or other facilities left in place, that information should be shared with the Design Manager, Sarah Schacher.
