NOW KNOW YE, that there is, therefore, granted by the UNITED STATES OF AMERICA, unto the above-named corporation the surface estate in the lands above described; TO HAVE AND TO HOLD the said estate with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said corporation, its successors and assigns, forever.

EXCEPTING AND RESERVING TO THE UNITED STATES from the lands so granted the subsurface estate therein, and all rights, privileges, immunities, and appurtenances, of whatsoever nature, accruing unto said estate pursuant to the Alaska Native Claims Settlement Act of December 18, 1971, 43 U.S.C. § 1613(f).

THE GRANT OF THE ABOVE-DESCRIBED LANDS IS SUBJECT TO:

1. Valid existing rights therein, if any, including but not limited to those created by any lease, contract, permit, right-of-way, or easement, and the right of the lessee, contractee, permittee or grantee to the complete enjoyment of all rights, privileges, and benefits thereby granted to him. Further, pursuant to Sec. 17(b)(2) of the Alaska Native Claims Settlement Act of December 18, 1971 (ANCSA), 43 U.S.C. § 1616(b)(2), any valid existing right recognized by ANCSA shall continue to have whatever right of access as is now provided for under existing law;
2. Requirements of Sec. 14(c) of the Alaska Native Claims Settlement Act of December 18, 1971, 43 U.S.C. 1601, 1613 (c), that the grantee hereunder convey those portions, if any, of the lands herein above granted, as are prescribed in said section.
3. The following third-party interest identified by U.S. Department of the Interior, Fish and Wildlife Service as provided by Sec. 14(g) of the Alaska Native Claims Settlement Act of December 18, 1971, 43 U.S.C. §1601, 1613 (g):

Permit M-36-YD for an Airport Right-of-Way issued to the State of Alaska, Department of Transportation and Public facilities, located in Secs. 19, 30, and 31, T. 1 N., R. 86 W., Seward Meridian, and Sec. 25, T. 1 N., R. 87 W., Seward Meridian, for the purpose of establishing, operating, and maintaining the Chefornak airport, formerly airport lease F-12088, issued under the provisions of the Act of May 24, 1928, as amended, 49 U.S.C. 211-214; and

4. Requirements of Sec. 22(g) of the Alaska Native Claims Settlement Act of December 18, 1971, 43 U.S.C. § 1621(g), that (a) the above-described lands which were on December 18, 1971, within the boundaries of the Clarence Rhode National Wildlife Range, Public Land Order No. 2213, now known as the Yukon Delta National Wildlife Refuge, remain subject to the laws and regulations governing use and development of such refuge, and that (b) the right of first refusal, if said land or any part thereof is ever sold by the above-named corporation, is reserved to the United States.
