3. THE BASIS OF ELEVATIONS IS THE OPUS AVERAGED GEIOD06 (NAVD88) ELEVATION OF 158.82 FEET AT CP #6, GALENA DIKE. GEIOD06 WAS DELIBERATELY USED SO THAT CONTROL INFORMATION CORRESPONDS WITH ROAD DESIGN DATA THAT WAS BASED ON GEIOD06 ELEVATIONS.

4. TO ESTABLISH PROJECT (GROUND) COORDINATES: THE INVERSE COMBINED SCALE FACTOR OF 1.000071290, DERIVED FROM AN AVERAGE OF ALL GPS CONTROL POINTS USING LEICA GEO OFFICE SOFTWARE VERSION 7.0, WAS APPLIED TO THIS PROJECT. A TRANSLATION OF -85.2758 M IN NORTHING AND -39.7937 M IN EASTING WAS USED TO PLACE THE SCALED COORDINATES BACK TO CP #2.

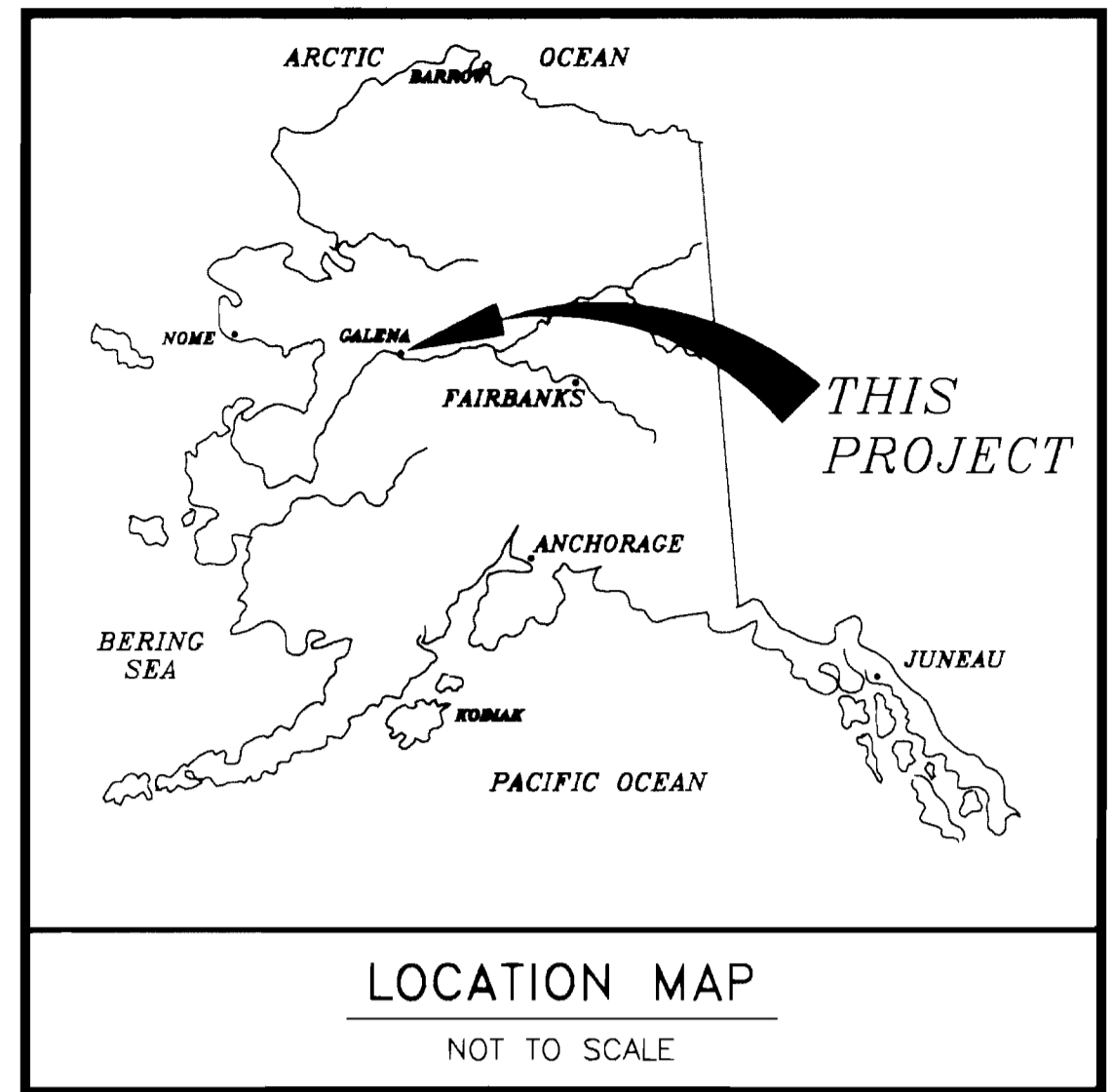
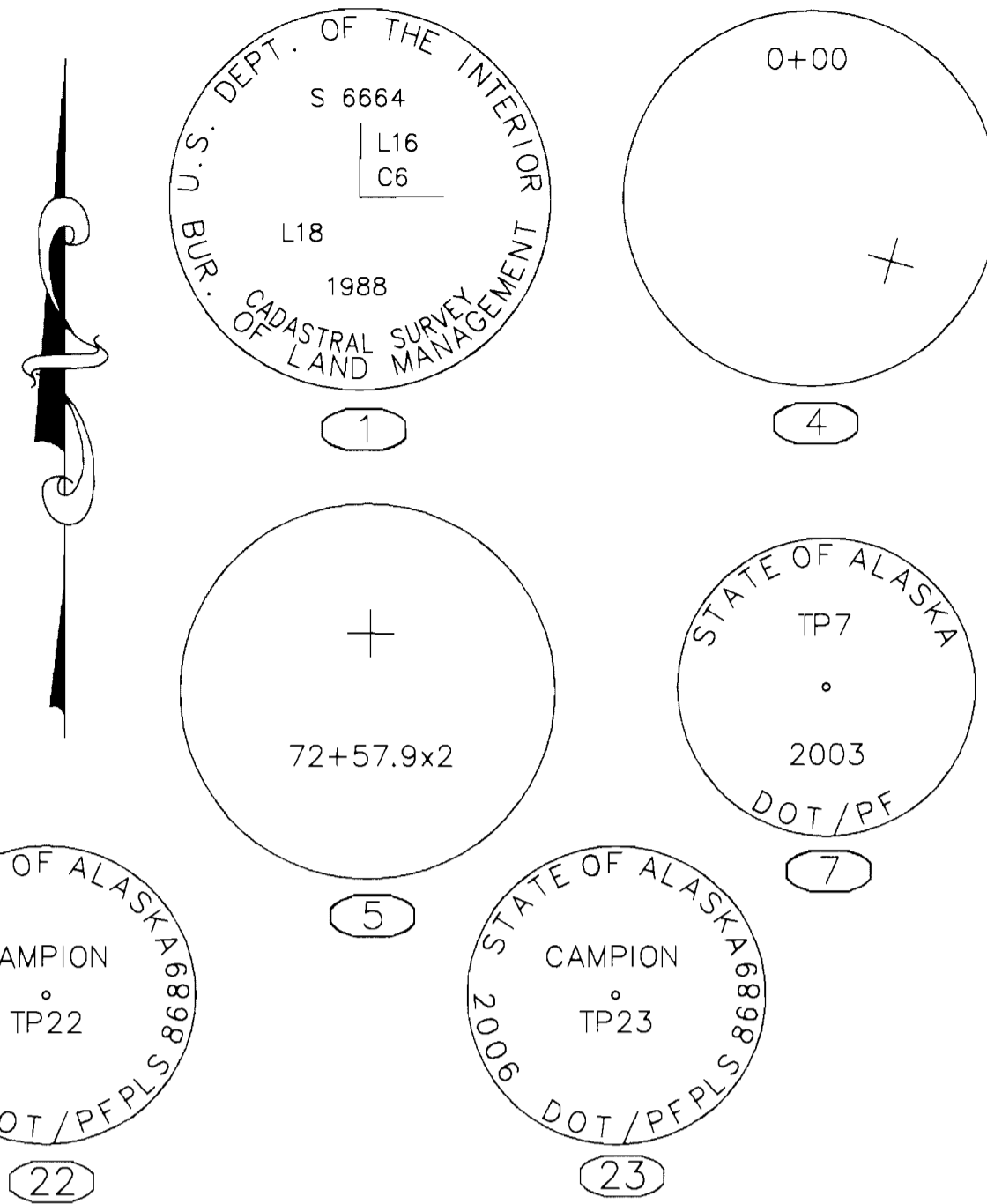

6. THE HORIZONTAL CLOSURE FOR THIS SURVEY MEETS OR EXCEEDS 1 PART IN 10,000. THE LARGEST NETWORK HORIZONTAL SEMI-MAJOR ERROR ELLIPSE OF 0.001 METERS AT THE 95% CONFIDENCE LEVEL WAS OBSERVED FOR THE STATIC GPS, AND THE MINIMUM LOOP MISCLOSURE MEETS OR EXCEEDS 1 PART IN 944,936.
