On April 23, 1990, a hearing was held at Nulato, Alaska, to determine the heirs and settle the estate of Robert G. Demoski, Sr., a deceased Athabascan.

The following findings and conclusions are based upon the evidence adduced:

The decedent, who was a resident of the State of Alaska, died at Galena, Alaska on August 18, 1973.

At death the decedent was possessed of that trust or restricted property, real and personal, shown on the inventory attached and other reporting documents, and the decedent was survived by certain persons whose respective names, relationships, birth dates, and interests in the estate under the Alaska statutes of descent, <u>Alaska Stat.</u> section 13.11.010(4), are as follows:
