Pursuant to Notice duly served and posted as required at 43 CFR 4.211 and 4.212, hearing of this matter was held at Nulato, Alaska, on September 3, 1991, to determine the heirs and settle the estate of Robert G. Demoski, Jr., deceased Athabascan Indian (decedent).

At the hearing, Edward Demoski, brother of decedent, testified under oath and evidence pertaining to the estate was received.

Findings and Conclusions based upon the evidence are as follows:

- 1. Robert G. Demoski, Jr., was born July 23, 1938, and died intestate at Galena, Alaska, on January 28, 1982. He was a resident of Galena, Alaska, at the time of his death.
- 2. Decedent never married and had no children, natural or adopted. Decedent's parents predeceased him.
- 3. Decedent was survived by a brother Edward Demoski B: 10/13/36, an adopted brother Victor Demoski B: 05/12/64 and an adopted sister Barbara Demoski Paquette B: 06/25/46.
- 4. Decedent was predeceased by a brother, Alfred Demoski B: 03/22/32, who died 06/05/75 leaving no children. Decedent was predeceased by a sister, Mary P. Demoski Pilot B: 07/28/33 and who died 02/07/71 leaving eight children, all of whom survived the decedent. Finally decedent was predeceased by a sister Ethel Demoski McGinty Brush B: 10/12/40, who was culturally adopted out of decedent's family and who died 04/25/84 leaving six children who survived decedent. Said six children are not heirs of decedent by reason of the adoption out of decedent's family of their mother. See Alaska Statutes § 13.11.045(1) et seq.
- 5. Decedent died possessed of a one-twelfth (8/96) interest in Pending Native Allotment Number F-13398 consisting of approximately 160 acres having an estimated appraised value of \$4,000, as appears more particularly in the certified Inventory and Appraisement filed herein, a copy of which is attached hereto. There was no money in the decedent's IIM account at the time of death.

ORDER

NOW, THEREFORE, By virtue of the power and authority vested in the Secretary of the Interior by Section 1 of the Act of June 25, 1910, as amended, 25 U.S.C. § 372 (1970), and other applicable statutes, and pursuant to 43 CFR Part 4, It is hereby ORDERED:

1. The Superintendent or other officer in charge shall distribute the estate to decedent's heirs in accordance with the findings and conclusions herein.

This decision is final for the Department unless a petition for rehearing is timely filed in accordance with 43 CFR 4.241 within 60 days from the date hereof as set forth in the notice attached hereto.
