The Inventory and Appraisement of Restricted Property dated December 12, 1990, did not include the decedent's interest in Native Allotment No. F13398. The Administrative Correction dated May 26, 1994, added the 1/72 interest he received through Lena Demoski, SA 89N-92, but omitted a 1/288th inherited interest which was subsequently received through William Paul, SA 70N-95.
