

**GAMBELL AIRPORT PAVEMENT REHABILITATION AND LIGHTING
AKSAS Project No. 60585**

REVISED DEED DESCRIPTION FOR TRACT IV
Permit, Avigation and Hazard Easement and Right of Way

In order to maintain continuity and make comparing the two descriptions more straight forward the following description is written in the same manner and order as the original. Some additional detail was added.

Tract IV

That certain real property lying and being within protracted Sections 3 and 10, Township 20 South, Range 67 West, Kateel River Meridian located in the Cape Nome Recording District, Second Judicial District, Gambell, Alaska and more particularly described as follows:

Commencing at Meander Corner No. 1, U.S. Survey No. 3728, Alaska, being common to Meander Corner No. 2, Lot 2, U.S. Survey No. 4369, Alaska;

Thence S 82°07'03" W, along the boundary common to said U.S. Survey No. 3728 and said Lot 2, U.S. Survey No. 4369, a distance of 360.10 feet, more or less, to the Witness Corner to Meander Corner No. 1, U.S. Survey No. 3728, being common to the Witness Corner to Meander Corner No. 2, Lot 2, U.S. Survey No. 4369, monumented with a Bureau of Land Management brass cap on an iron post;

Thence continuing S 82°07'03" W, along the boundary common to said U.S. Survey No. 3728 and said Lot 2, U.S. Survey No. 4369, a distance of 602.73 feet, more or less, to Meander Corner No. 3, Lot 2, U.S. Survey No. 4369;

Thence N 16°23'28" W, along the meander of the shore of the Bering Sea, a distance of 567.24 feet, more or less, to Meander Corner No. 4, Lot 2, U.S. Survey No. 4369;

Thence N 82°07'03" E, along the northern boundary of said Lot 2, U.S. Survey No. 4369, a distance of 160.86 feet, more or less, to the TRUE POINT OF BEGINNING;

Thence continuing N 82°07'03" E, along the northern boundary of said Lot 2, U.S. Survey No. 4369, a distance of 769.40 feet, more or less, to a point which lies 116.50 feet, more or less, S 82°07'03" W from Corner No. 1, Lot 2, U.S. Survey No. 4369, being common to Corner No. 4, Lot 3, U.S. Survey No. 4369;

Thence N 0°40'08" E, a distance of 810.82 feet, more or less, to a point;

Thence S 82°08'18" W, perpendicular to the centerline of the Gambell Airport Runway, a distance of 1010.00 feet, more or less, to a point;

Thence S 16°23'33" E, a distance of 811.10 feet, more or less, to the TRUE POINT OF BEGINNING.

Said real property having an area of 16.380 acres, more or less.
