## 4.0 Transportation Facility Needs

### 4.1 1993 JATP and 2005 Updated Road Inventory Priorities

The list of existing and proposed routes not already in the IRR inventory is presented in the following pages and is hereby requested to be included into the IRR inventory. The Tribe retains the right, in its sole discretion, to change the order of its route priorities if and when construction funds become available; dependent upon village conditions.

- Priority 1: BIA Route 0027 – Lutak Inlet Road, 5.5 miles
- Priority 2: BIA Route 0028 – Lutak Highway, 4.0 miles
- Priority 3: BIA Route 0036 – Front/Beach road, 2.1 miles
- Priority 4: BIA Route 0039 – Mud Bay Road, 7.9 miles
- Priority 5: BIA Route 0041 – Chilkat State Park Road, 2.0 miles
- Priority 6: BIA Route 0025 – Upper Chilkoot Road, 8.7 miles
- Priority 7: BIA Route 0033 – Deishu Drive, .2 miles
- Priority 8: BIA Route 0030 – Beach road/ Main Street, 1.4 miles
- Priority 9: BIA Route 0029 – Second Ave/ Union Street, .8 miles
- Priority 10: BIA Route 0031 – Third Ave/Young Road, 1.9 miles
- Priority 11: BIA Route 0032 – First Ave /Mission St/Third Ave, .7 miles
- Priority 12: BIA Route 0034 – Second Ave, .5 miles
- Priority 13: BIA Route 0035 – FAA Road, .9 miles
- Priority 14: BIA Route 0040 – Small Tracts Road, 1.7 miles
- Priority 15: BIA Route 0044 – Sawmill road, .4 miles
- Priority 16: BIA Route 0005 – Eagle Bluff Drive, 1.4 miles
- Priority 17: BIA Route 0026 – Chilkoot River Road, 1.1 miles
- Priority 18: BIA Route 0003 – Haines Highway, 20.2 miles
- Priority 19: BIA Route 0043 – Chilkoot Cultural Interpretive Trail, 1.3 miles

**TITLE: ADOPT THE FY2005 CHILKOOT INDIAN ASSOCIATION

WHEREAS, Transportation plays an integral role in serving local infrastructure and community needs; and

WHEREAS, The Chilkoot Indian Association is the Federally recognized body of the Tribal Members of Haines, Alaska; and

WHEREAS, The Chilkoot Indian Association desires to provide adequate transportation facilities to meet the needs of residents of Haines, Alaska; and

WHEREAS, The Chilkoot Indian Association has worked with ASCG, Inc. to develop the Chilkoot Transportation Plan which includes updated village characteristics and conditions, identifies transportation needs and priorities, and contains mapping with land use updates, planned land use, and planned road priorities; and

WHEREAS, The Chilkoot Indian Association agrees with the needs and priorities presented in The Chilkoot Transportation Plan; and

NOW THEREFORE BE IT RESOLVED,

That the Chilkoot Indian Association adopts the Chilkoot Transportation Plan.
