Resolution No. 05-02

- WHEREAS, the Chilkoot Indian Association (hereinafter "Tribe") is a federally recognized Tribe; and
- WHEREAS, the Chilkoot Indian Association is the governing body of the Tribe; and
- WHEREAS, the Tribe qualifies for services and benefits under both the Indian Reservation Roads (IRR) and IRR Road Maintenance programs; and
- WHEREAS, the Bureau of Indian Affairs (BIA) is responsible for updating the IRR inventory when a tribe determines there is a need for BIA system change; and
- WHEREAS, the Tribe has identified a need to update and/or create mileage in the BIA system for the Tribe; and
- WHEREAS, the Tribe has identified roads that qualify as Indian Reservation Roads; and
- WHEREAS, the Tribe has identified IRR roads that are vital to the general health and welfare of the native community and its economic development.

NOW, THEREFORE, BE IT RESOLVED, that the Chilkoot Indian Association hereby requests the BIA to add the roads identified below to the BIA's Inventory of Indian Reservation Roads as BIA system roads:

BE IT FURTHER RESOLVED, that the Tribal Council hereby authorizes William Thomas on behalf of the Chilkoot Indian Association to sign any Project Scoping and Planning Reports for each of the above -mentioned roads.
