UTILITY PASSMENT

KNOW ALL HEN BY TRESE PRESENTS:

That in consideration of TEN DOLLARS (\$10.00) and other good and valuable consideration paid to THOMAS W. MAHER, P.O. Box 648, Fairbanks, Alaska 99707, hereinafter referred to as the GRANTOR, by the CITY OP HORTH POLE, a municipal corporation of the State of Alaska, hereinafter referred to as the GRANTEE, the receipt of which is hereby acknowledged, the GRANTOR does hereby GRANT, BARGAIN, SELL, TRANSFER and CONVEY unto the GRANTEE, its successors and assigns, a perpetual easement to construct and lay sewer and water mains and appurtenances, and thereafter use, operate, inspect, repair, maintain, replace and remove the same over and across and through the land of the GRANTOR situated in the Fairbanks Recording District, State of Alaska, which said easement and right of way is described as follows:

Those portions of land located within the Northeast quarter of Section 6, Township 2 South, Range 2 East, Pairbanks Meridian, Alaska, more particularly described as follows:

PORTION A: The Southerly 25 feet and the Westerly 25 feet of the South half of the Southeast quarter of the Southeast quarter of the Northeast quarter of Section 6;

PORTION B: The Southerly 25 feet of the Westerly 25 feet of the North half of the Southeast quarter of the Southeast quarter of the Northeast quarter of Section 6;

PORTION C: The Southerly 25 feet and the Westerly 25 feet of the North half of the Southwest quarter of the Southeast quarter of the Northeast quarter of Section 6;

PORTION D: The Westerly 25 feet of the North half of the Southeast quarter of the Northeast quarter of Section 6;

PORTION E: Commencing at the Northeasterly corner of said Section 6;

Thence Westerly along the Northerly line of said Section 6 a distance of 785.9 feet, more or less, to the Southeasterly line of that parcel taken by the Pairbanks North Star Borough for the Chena River Lakes Plood Control Project, by Declaration of Taking filed October 16, 1974, in Superior Court, State of Alska, Pourth Judicial District, Cause No. 74-946, and the true point of beginning:

Thence South 24037' West along the said Southeasterly line a distance of 1210.7 feet to the beginning of a curve concave to the Southeast having a radius of 440 feet;

Thence Southwesterly along the said Southeasterly line 189.97 feet along said curve (through an angle of $24^{\circ}45^{\circ}$) to a point;

Thence South $00^{\circ}08^{\circ}$ East a distance of 35.24 feet, more or less, to the South line of Government Lot 2 of Section 5;

Thence East along said South line a distance of 12.5 feet, more or less, to the Southwest corner of Government Lot 1;

Thence East along the South line of Lot 1 a distance of 25.00 feet, to a point; Fairbanks Recording District

Thence M 06°51'12" East a distance of 210.64 feet, more or less, to a point which lies offset 25 feet Southeasterly from the said Southeasterly line of the Chena River Lakes Flood Control Project;

Thence North 24°37' Bast, parallel to said Southeasterly line a distance of 1222.15 feet, more or less, to the North line of Section 6;

Thence West along said North line a distance of 27.50 feet, more or less, to the true point of beginning.

PORTION P: The Northerly 25 feet of the Easterly 785.9 feet of Section 6.

The consideration hereinabove recited shall constitute payment in full for any damages to the land of the GRANTOR, its successors and assigns, by reason of the installation, operation, and maintenance of the structures or improvements referred to herein. The GRANTEE covenants to maintain the perpetual easement in good repair so that no unreasonable damage will result from its use to the adjacent land of the GRANTOR, its successors and assigns.

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the GRANTED, its successors and assigns.
