

DeAvila, whose mailing address is 2829 Plack Rd, North Pole, AK 99705, for and in consideration of SIX HUNDRED AND FIFTY (\$650.00) DOLLARS, and other valuable consideration, in hand paid, conveys and warrants to the GRANTEE, STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES, whose mailing address is 2301 Peger Road, Fairbanks, Alaska 99709, its successors or assignees, a perpetual, full and unrestricted easement and right-of-way along, over, under, and across the following-described tract of land located in the State of Alaska:

That certain real property lying and being within Lot 1, Block 3, Woodland Subdivision, recorded as Plat 60-4152, June 7, 1960, Fairbanks Recording District, all within Section Four (4), Township Two South (T2S), Range Two East (R2E), Fairbanks Meridian, Alaska, Fairbanks Recording District, Fourth Judicial District, State of Alaska, known as Parcel E1 of Alaska Project No. STP-0002(214)/77248, "Plack Road Bike/Pedestrian Facility", more particularly described as follows:

**BEGINNING** at a point on the centerline of Alaska Project No. STP-0002(214)/77248, Station "O1" 20+65.90;

**THENCE** S 01°16'38" W on a line perpendicular to centerline a distance of 32.58 feet to the southerly right of way line of Plack Road, named Lincoln Road in Plat 60-4152, and a corner common to Lot 4A, D&L Subdivision, recorded as Plat 2007-56, April 3, 2007, Fairbanks Recording District and Lot 1 Block 3, Plat 60-4152, and the **TRUE POINT OF BEGINNING**;

**THENCE** S 88°42'08" E along the right of way line of Plack Road a distance of 120.00 feet to the right of way line of Valinda Street, named Washington Street in Plat 60-4152;

**THENCE** S 01°04'02" W along the westerly right of way line of Valinda Street, a distance of 17.00 feet;

**THENCE** N 88°42'08" W a distance of 120.02 feet to the easterly boundary line of Lot 4A, D&L Subdivision, recorded as Plat 2007-56, April 3, 2007, Fairbanks Recording District;

**THENCE** N 01°08'23" E along the boundary line common to Lot 1 and Lot 4A a distance of 17.00 feet to the right of way line of Plack Road and the **TRUE POINT OF BEGINNING**;

Said described parcel contains 2,040 square feet, more or less.
