

That certain real property lying and being within Lot 2, Block 2, Woodland Subdivision, recorded as Plat 60-4152, June 7, 1960, Fairbanks Recording District, all within Section Four (4), Township Two South (T2S), Range Two East (R2E), Fairbanks Meridian, Alaska, Fairbanks Recording District, Fourth Judicial District, State of Alaska, known as Parcel E2 of Alaska Project No. STP-0002(214)/77248, "Plack Road Bike/Pedestrian Facility", more particularly described as follows:

THENCE S 88°42'08" E along the right of way line of Plack Road a distance of 120.00 feet to the right of way of the alley, Plat 60-4152;

THENCE S 01°04'02" W along the westerly right of way line of the alley a distance of 17.00 feet;

THENCE N 88°42'08" W a distance of 120.00 feet to the right of way line of Valinda Street, named Washington Street in Plat 60-4152;






