**ROAD EASEMENT**

The Grantors, KENNETH EUGENE EASTON and PATRICIA ALILON EASTON, husband and wife, of North Pole, Alaska, hereby grants and reserves to public use forever an easement for roadway purposes across the north twenty feet of a portion of the parcel of land described in the Instrument recorded on August 20, 1977 in Book 68, Page 456, Instrument #77-05355, Records of the Fairbanks Recording District, State of Alaska, and more particularly described as follows:

A portion of the Southeast Quarter of Section Six, Range Two East Fairbanks Meridian in Township Two South, more particularly described as follows:

Post #1 is located 238 feet West along the South boundary of the SE 1/34 of Section 6, Range 2 East, Fairbanks Meridian. THENCE West from Post #1 178 feet along the South boundary of SE 1/4 Section 6 Range 2 to Post 2. THENCE North 208 feet parallel to the East boundary of SE 1/4 Section 6 Range 2 to Post #3. THENCE East 238 feet parallel to the South boundary of SE 1/4 Section 6 Range 2 to Post #4, and THENCE Southwest to Post #1: the point of beginning. Commonly known as Tax Lot 645.

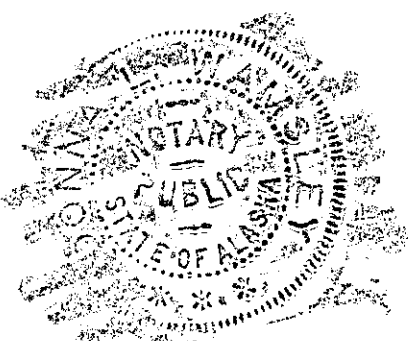
