EV-3-267 is another one of the "Lakes" projects where the State acquired title to numerous USS lots and 50 SLEs attached to protracted section lines when we acquired title.

The one I think you are referring to is a RS2477 SLE vacation in Pt Alsworth EV-3-280 where we are asserting SLEs on protracted section lines. I mentioned that one the other day.
