Gerald, the note on the Richardson Hwy MP 148-173 plans was taken from the previous Tok Cutoff MP 110-124 plans. At that time, Larry King was administering a contract for ROW plan production with ASCG (Karen Tilton). Larry's emails indicate that he conferred with Joe Kemmerer on March 21, 2003 regarding the status of SLE's for protracted sections. Joes opinion at the time was that the SLE's existed as per the 1969 AGO Opinion subject to the location at the time of the survey. Larry's email then said that he spoke with you on April 1, 2003 and that your opinion was that the SLE's do not exist for protracted section until either the line is surveyed or until a reservation of the easement is make at the time of conveyance form the state. This was consistent with the never officially approved November 19, 1986 Department Order #111. So it appears that the conclusion Larry reached from his conversation with you was that DNR was holding the Departmental Order as an appropriate statement, but it had just never been formalized. In that respect we do need to change our note to delete the reference to the Order #111 and refer to the statement as DNR's informal policy on that matter. Do you agree with that or have some language that would appropriately get across what DNR's position is with regard to the protracted SLE's? Thanks, JohnB

I came across it while reviewing a project plan for the ADOT on the Richardson highway. RICH HWY MP 148-173 F-071-3(10) is the Alaska project number through ADOT, John Bennett is the right-of-way person listed on the project cover sheet. Within the General notes for the surveyor, item #12, addresses section line easements through protracted sections of State lands, and it states that the DNR issued the order #111. It simply states that a section line easement does not exist until it is either located by survey or is reserved in a conveyance document when in a protracted section of state land.

Might want to talk to John Bennett at ADOT right-of-way section, and make sure he has the correct status of such an order. Thanks for the answer, was just wanting the information for personal knowledge, but might have saved you all some trouble in the future if it has never been issued.
