A parcel of land located within Section 2, Township 27 North, Range 26 West, Kateel River Meridian, Kotzebue Recording District, Fourth Judicial District, State of Alaska, known as Parcel No. 7 of Alaska Project No. 0002384/NFHWY00162 (Project) and more particularly described as follows:

**COMMENCING** at a Department of the Interior 3-1/4” brass cap on a 2-1/2” iron pipe, said monument being the corner common to Section 1 of Township 27 North, Range 26 West; Section 6 of Township 27 North, Range 25 West; Section 36 of Township 28 North, Range 26 West and Section 31 of Township 2 North, Range 25 West, Kateel River Meridian;

**THENCE** S 50°11’57” W a distance of 8,507.91 feet to the point of intersection of the south line of protracted Section 2 and the westerly right-of-way line (ROW) for the Kivalina Evacuation Road, said point being offset 150.00 feet left of station 191+17.55 and the **TRUE POINT OF BEGINNING**;

**THENCE** N 48°27’11" E along the Project ROW line a distance of 1,000.68 feet;

**THENCE** northeasterly along the Project ROW line on a curve to the left having a radius of 383.00 feet, a central angle of 38°56’51", an arc length of 260.35 feet and a chord length of 255.37 feet bearing N 28°58’45" E;

**THENCE** N 9°30’20" E along the Project ROW line a distance of 312.20 feet;

**THENCE** northeasterly along the Project ROW line on a curve to the right having a radius of 683.00 feet, a central angle of 15°39’11", an arc length of 186.59 feet and a chord length of 186.01 feet bearing N 17°19’55" E;

**THENCE** N 25°09’31" E along the Project ROW line a distance of 848.24 feet to the north line of protracted Section 2;

**THENCE** S 1°28’00" E along the north line of protracted Section 2 a distance of 669.42 feet to the easterly Project ROW line;

**THENCE** S 25°09’31" W along the Project ROW line a distance of 249.82 feet;

**THENCE** southwesterly along the Project ROW line on a curve to the left having a radius of 383.00 feet, a central angle of 15°39’11", an arc length of 104.64 feet and a chord length of 104.31 feet bearing S 17°19’55" W;

**THENCE** S 9°30'20" W along the Project ROW line a distance of 312.20 feet;

**THENCE** southwesterly along the Project ROW line on a curve to the right having a radius of 683.00 feet, a central angle of 38°56'51", an arc length of 464.28 feet and a chord length of 455.39 feet bearing S 28°58'45" W;

**THENCE** S 48°27'11" W along the Project ROW line a distance of 644.92 feet to the south line of protracted Section 2;

**THENCE** S 88°35'34" W along the south line of protracted Section 2 a distance of 465.36 feet to the **TRUE POINT OF BEGINNING**.

Parcel 7 contains 15.096 acres more or less.
