## THE GRANT OF THE ABOVE-DESCRIBED EASEMENTS IS SUBJECT TO:

All the terms and conditions and limitations set forth in Exhibits C, D and G of the Agreement. A copy of this agreement will be found in case file F-84520, and is recorded in the Kotzebue Recording District, Book 30, Pages 807-922 and Book 35, Pages 437-442.

- a. The easements are identified as Trail A and Trail B. Trail A originates in the village of Kivalina and is a northerly route across the Cape Krusenstern National Monument to the village of Noatak. Trail B also originates in the village of Kivalina and is a southerly route across the Cape Krusenstern National Monument to the village of Noatak.
- b. The easements are intended to connect to other easements over adjacent lands to form two continuous trail easements between the villages of Kivalina and Noatak.
- c. The easements are 25 feet wide and restricted to travel by foot, dogsled, animals, snowmobiles, two- and three-wheeled vehicles, and small all-terrain vehicles (hereinafter ATV'S) less than 3,000 lbs. Gross Vehicle Weight (GVW).
- d. Use of the easements by snowmobile and two- and threewheeled vehicles and ATV's shall occur only during that period of the year when snow depth or a combination of snow depth and frost depth is sufficient to protect the underlying vegetation and soil as determined by the Superintendent, Cape Krusenstern National Monument. No vehicle may be used on the easement that causes substantial damage to or loss of vegetation and soil.
- e. The general public, the National Park Service, its contractors or permittees, and the State of Alaska shall have the right of access along these trail easements.

- f. The purposes for which the trail easements may be used are limited to access for Monument purposes, including public visitation; subsistence uses as that term is defined in § 803 of the Alaska National Interest Lands Conservation Act, 94 Stat. 2371, 2423, by residents of the Cape Krusenstern National Monument resident zone; and for local noncommercial intervillage travel between the villages of Kivalina and Noatak.
- g. Camping is permitted within or reasonably near the easements, if necessary, while enroute.
- h. The right to develop and improve these easements on land owned by the United States shall be the exclusive right of the United States but there shall be no duty on the United States to develop or improve such easements.
- i. The United States reserves the right on lands under its jurisdiction within the Monument to mark the trail easements on the ground or relocate them within a reasonable distance in order to protect monument resources, for purposes of public safety or enjoyment or to bypass any valid existing rights blocking the easements.
- j. The two easements reserved across the lands described in this document are subject to the right of the United States to control uses on the reserved easements to further management objectives of the Cape Krusenstern National Monument.


