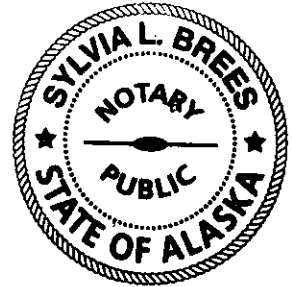
STATUTORY QUIT CLAIM DEED
