To all to whom these presents shall come, Greeting:

WHEREAS, a Cortificate of the Land Office at Fgirbanks, Alaska, is now deposited in the Eureeu of Land Management, whereby it appears that, pursuant to the Ast of Congress of May 20, 1862, "To Secure Homesteads to Astual Settlers on the Public Domain," and the acts supplemental thereto, the claim of Lowis E. Jahns has been established and duly consummated, in conformity to law, for the following described land:

Fuirbanks Meridien, Alaska.

7. 7 S., R. 8 R., sec. 35, lots 2 & 3, Swing, Brisk, Maisk, Maisk. The area described contains 145.94 scres, according to the Official Plat of the Survey of the said Land, on file in the Bureau of Land Management:

NOW ENCH YE, That there is, therefore, granted by the UNITED STATES unto the said Louis E. Jahns the treet of Land above described; TO HAVE AND TO HOLD the said tract of Land, with the appurtenences thereof, unto the said Lowis E. Jahns and to his heirs and assigns forever; subject to any vested and accrued water rights for mining, agriculturel, manufacturing, or other purposes, and rights to ditches and reservoirs used in connection with such water rights, as may be recognized and acknowledged by the local customs, laws, and decisions of courts; and there is reserved from the lands here by granted, a right of way thereon for ditches or canals constructed by the authority of the United States. And there is also reserved to the United States a right of way for the construction of railroads, telegraph and telephone lines, in securdance with the Act of March 12, 1914 (38 Stat. 305). Excepting and reserving, also, to the United States, pursuant to the provisions of the Ast of August 1, 1946 (60 Stat. 755), all uranium,



therium or any other material which is or may be determined to be poculiarly essential to the production of fissionable materials, whether or not of commercial value, together with the right of the United States through its authorized agents or representatives at any time to enter upon the land and prospect for, mine, and remove the same. And there is reserved from the lands hereby granted, a right of way thereon for roads, medways, highways, tramays, trails, bridges, and appurtenant structures constructed or to be constructed by or under authority of the United States or of any State created out of the Territory of Alaska, in accordance with the Act of July 24, 1947 (61 Stat. 418). Excepting and recerving, also, from this conveyance that certain pipeline and telephone line and all appurtenances thereto, constructed by the United States through, ever or upon the northwest quarter of the southeast querter and the northeast querter of the southwest querter of said 500tion thirty-five, and the right of the United States, its officers, agents or employees to maintain, operate, repair or improve the same so long as meded or used for or by the United States.
