## Notice of Public Meetings and Comment on Klutina Lake Road and Gulkana Proposed Settlement

The State of Alaska is seeking public comment on a proposed settlement with Ahtna, Inc. regarding public access along the Klutina Lake Road and the Gulkana River near the Historic Gulkana Village. The proposed settlement would end pending litigation between Ahtna and the State of Alaska regarding property interests in and uses of Klutina Lake Road, and resolve long-standing impacts to the historic Gulkana cemetery and townsite.

The State of Alaska and Ahtna Inc. will review the public comments and if appropriate, modify the agreement before it is finalized and signed.

- Thursday, August 3, 2017, from 6 P.M. to 8 P.M. in Meeting Room 1-3, Curtis D. Menard Memorial Sports Center, at 1001 S. Clapp Street, Wasilla, AK
- Monday, August 7, 2017, from 6 P.M. to 8 P.M. in the Noel Wien Library auditorium, located at 1215 Cowles Street, Fairbanks, AK
