Under separate cover are being sent to you today a supply of voucher forms for use in settling accounts for work done under supervision of your office. The method of using such vouchers will doubtless be clear to you, but we are enclosing a sample partly filled in for your better guidance. They are provided in original and duplicate, the latter to be retained as a record of your own office, the former to be sent in to the Governor for his approval from where it will be sent to this office and the office of the Secretary by whom a warrant on the Treasurer will be sent to the party to whom the Territory is indebted.

I am advised by the office of the Secretary that printed copies of the law under which your office will operate were mailed out to the Road Commissioners on June 12th. Many of the provisions of the law are rather vague, but so far as possible you must be governed by such provisions. It is provided that Commissioner shall furnish bond but no amount is provided, nor is it provided to whom the bond shall run or who shall be the custodian of such bond.

The Commissioner of this First Division referred these matters to the Governor, who, however, declined to assume any responsibility in the matter, but offered as a suggestion merely, that as the Commissioners under terms of the Act apparently handled no money that a bond in nominal amount for faithful performance of duty only, be furnished, and further suggested amount of \$2,000.00. Bond in this amount and of the character mentioned we are advised were prepared and sent to the Judge of the Fistrict Court for his approval. Upon approving the Judge deemed it an official proceeding and the bond was placed on file in the records of the office of the Clerk of the Court. Should you follow the same proceedure, we should be advised by the Clerk of the Court.

According to the amount which was in the Forest Reserve Fund at time of effectiveness of the Act reating Road Districts in Alaska, the amount to be apportioned to each road district, and which is available at this time will be \$11,310.80. This amount is all that will be available for this season as the receipts for the year of 1915 will not be at hand until too late for use this season. Annual amounts too will quite likely be much less than for this year, as the present sum is an accumulation of several years receipts. Please kindly advise this office if there is any thing in the above not entirely clear to you.

Yesterday I was served with complaint in suit which has been brought to have declared void Act of the Territorial Legislature creating road districts in the Territory of Alaska and appropriating moneys in the Forest Reserve Fund for the building, repairing and maintaining of trails, roads and bridges throughout the Territory.

Upon consultation with Mr. J. H. Cobb, who has been designated by the Governor as legal counsel for the Territory, I sent you notification of such suit by telegram, which I now confirm, as follows:

"Suit filed enjoining payment road money letter follows."

Governing the conduct of this office in the matter, I am advised by Mr. Cobb as follows:

"---, I beg to advise you, that while no temporary injunction has been served, still, in my opinion, it is proper for you to hold the Forestry Tund mentioned in the complaint in statu quo, until the validity of the appropriation of the fund made by the last legislature is passed upon. You should notify the several Road Commissioners of the facts, so that they may govern themselves accordingly."

I am further advised by our legal counsel that he will appear in the suit at as early a date as possible and press the cause to a speedy hearing that final decision may be arrived at as soon as practicable. While matters remain as they are, this office must be governed by epinion of counsel. You will be advised from time to time of any material change in the situation, by telegraph if deemed neccessary.

At the last session of the Legislature a bill was enacted creating Road Districts in Alaska and appropriating moneys from the Forest Reserve Fund of the Territorial Treasury for use in carrying out the provisions of such bill. The bill provided for the appointment of a Road Commissioner in each district by joint resolution of the two branches of the Legislature, and Mr. Ed. Wood of Valdez, was appointed Commissioner in the Third road district.

The bill further provides for bond to be furnished by the Read Commissioners, such bond to be approved by the Judge of the District Court of the division of the Territory in which such Road Commissioner is situated. The bill is extremely indefinite in regard to this bond, specifying no amount or custodian. In the divisions where such bond has been furnished, the Judge has approved and ordered retained as a court record, the Clerk of the Court advising this office of such approval, amount of the bond and as to its being filed.

This office has addressed several telegrams and letters to Mr. Wood, but up to this time has received no word from him. By return mail, will you kindly advise if any thing has been done in your office in connection with Mr. Wood's bond? We would also appreciate some information in regard to him also, whether or not he is in Valdez, and if he has done any work under provisions of bill creating his office.



From the office of the Governor I am in receipt of voucher in duplicate in favor of Bartley Howerdamounting to \$1,600.00 in settlement for road work done near Cordova, Alaska, the voucher being certified by yourself and your assistant commissioners and accompanied by copy of preliminary notices and contract under which the work was done.

Upon inspection and comparison of the voucher and contract, I find them not to be in accord, and they are herewith being returned for correction in certain details the reason for which I will explain as follows:

Your voucher contains statement of certain road work done consisting of grading, filling and building of bridges, these latter constructed of "sawn timber", all for a total amount of \$1,600.00.

Had Mr. Howard's bid and contract provided for the performance of all this work for the flat amount named, the voucher would be in order, but I find that his contract provides for the labor of a certain number of men with suitable tool, for a certain number of days at \$6.00 per day; a foreman at \$8,00 per day for a certain number of days, and the services of a temm, with driver for same and wagon, plow and scraper. In the contract there is no mention of any material to be furnished.

Under this contract then there should be specified in the

the voucher a brief description of the work done, the locality in which it was done, followed by a statement of the number of men employed, total number of working days at rate per day contracted for, also same for team with driver and foreman, a summary of the total being the amount due the contractor under the contract, all to be certified by you and approved by your assistant commissioners.

In this instance, inasmuch as your voucher is all made up and certified, it will suffice if, with the other papers supporting the voucher, you will supply us with a further one showing the detail mentioned above, same to be made up by you or the contractor and approved by the assistant commissioners. Though there is mention made of bridge material in Mr. Howards voucher, I take it that no material was furnished by him, and that this matter has been covered by a separate contract.

I am advised by the Governor's office that this voucher has been previously returned to you for correction in certain details and because of not having been accompanied by the contract, and I regret exceedingly the neccessity for this secondary return and the incident delay in its settlement. However, I trust you will appreciate the difficult position in which the writer is placed, the liability of this office to investigation and criticism at any time, and, as a consequence, the neccessity of having all matters in regular and proper form before cash disbursements can be made upon them. I presume that some few difficulties are to be expected in the beginning of a new matter such as this, but that they will be overcome as we all get into the work.

Upon your furnishing us with the additional matter in support of Mr. Howard's voucher, as explained above, warrant in it's settlement will be promptly issued and forwarded to him at the address furnished in your letter of Nov. 22d to this office.

The Three enclosed vouchers have been submitted to this office for inspection prior to their approval by the Governor, and such inspection showing them to be lacking in certain details, all are herewith enclosed for correction.

The contract attached to voucher in favor of Andrew Nelson provides for services of four men at \$6.50 per day for 30 days; one man with team and use of wagon, etc., at \$13.00 per day, also foreman at \$7.00 per day for the stipulated time. Your voucher makes mention of "thirty days work performed by crew of five men and two horses according to contract. It makes, however, no mention of the foreman. A Attached to the voucher you will find a memorandum statement which I have prepared in accordance with the contract. A similar statement on the voucher or attached thereto, properly certified, will place it in proper shape for approval and payment. Similar corrections in the voucher in favor of Pat. Murphy are neccessary before it can be approved and paid.

In the matter of the voucher to Gus. F. Johnson for \$300.00 as salary while acting as assitant commissioner on Kotsina and Chisana trails, beta Governor Strong and myself think the voucher should be supported by more detail. That is, should specify the dates between thech the work was performed, the number of days engaged and amount per day, and any other information which it might occur to you would be useful in apssing upon this matter.

I note wording in your contracts which seems to me rather un-

fortunate and which I would suggest be changed in subsequent contracts. The wording referred to is on the second page of the contract and is as follows; "All payments to be made in duplicate vouchers properly signed by the persons performing the labor, etc." From this wording it might be taken that payments were to be made direct to each individual workman, whereas it is only the contractor who is to be settled with in such manner

Upon return of these vouchers properly corrected in accordance with above instructions, they will be promptly passed and approved for payment. I trust that we will soon get these matters systematized so that these delays may not be neccessary.
