

NOTICE OF UTILIZATION

COMES NOW the STATE OF ALASKA, acting by and through its Department of Public Works, and by these presents does hereby give notice to James R. & Helen Day, the owner, entryman or other party entitled to the possession thereof, as the same is indicated of record, of the utilization of the following described real property located in the 4th Fairbanks Recording Precinct, Fourth Judicial Division, State of Alaska, and more particularly described as follows:

45 A part of a certain tract or parcel of land lying and being situate in the E $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 29, T.1N., R.2E., F.M., Fourth Judicial District, State of Alaska, being more particularly bounded and described as follows, to-wit:
Beginning at a point on the center line of FAS Route No. 650 said point being S.89°54'W. along the latitudinal quarter line of Section 29, T.1N., R.2E., F.M. a distance of 1948.2 feet from the east quarter corner of Section 29; thence continuing S.89°54'W. along the latitudinal quarter line a distance of 136.0 feet to a point on the right right of way line of Alaska Project No. S-0650(7); thence northwesterly along a 6°14' curve to the right (radius = 918.57 feet) through an arc of 0°56' a distance of 15.1 feet to a point of tangent; thence N.38°52'W. a distance of 2737.1 feet to a point of curve; thence northwesterly along a 5°29' curve to the left (radius = 1046.0 feet) through an arc of 5°12' a distance of 94.9 feet; thence N.89°53'E. a distance of 262.0 feet to a point 100.0 feet left and perpendicular to center line Station 372+65.7; thence S.38°52'E. an approximate distance of 1569.3 feet to a point on the center line of FAS Route No. 650; thence southeasterly along the center line of FAS Route No. 650 to the point and place of beginning.

Containing 9.207 acres, more or less, of which 0.915 of an acre, more or less, is contained in FAS Route No. 650. Net area equals 8.292 acres, more or less.

The STATE OF ALASKA declares that the above described real property is utilized for the purpose of a right of way thereon for roads, roadways, highways, tramways, trails, bridges, and appurtenant structures pursuant to the Act of Congress, 61 Stat. 418, effective July 24, 1947, (48 U.S.C. 321d); and no crops or improvements of any kind or description may be placed or erected thereon.

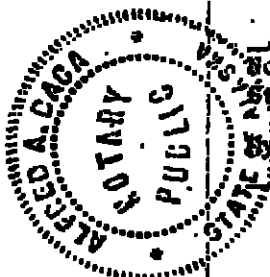
