Garry, this was actually a bit of a challenge. I haven't really considered these numbered routes before because they really didn't seem to have much to do with the historical documentation. There are several sets of pre-statehood route numbering schemes that are important to cross reference so you can track them over time when doing ROW research but these numbered routes didn't really seem to come from those systems. You've likely seen some references to them on the internet where people comment that they exist but that most Alaskans don't know much about them because the routes are more commonly called just by their names. I had found some indications that the numbered routes were a part of an AASHTO scheme and then I found a reference to one of our own DOT manuals, specifically, the Alaska supplement to the MUTCD that is also a part of the Alaska Traffic Manual. I have copied 4 pages from that manual and attached them. They verify that the numbering policy came from AASHTO. North-South routes were supposed to be odd numbers and E-W routes even numbers, but its not really consistent. They are also to be continued to make the longest routes which is odd because Route 2 ends up being the Alaska Highway, then Richardson Highway, then Steese Highway then Elliott Highway. I suspect not many folks know that or why. The other attachment is the AASHTO numbering policy which provides some guides as to how the routes should be numbered. This is all interesting because it doesn't seem to have a lot of value, at least not from a planning or ROW research point of view. Hope all this helps answer your question. JohnB
