- 4/14/75 Spotts called State Troopers. Sgt. Hussey reconfirmed appointment for tomorrow. Called H & S Warehouse and reconfirmed.

4/15/75

Sharon McLeod and Helen Spotts met Trooper Robert Woodbury at 309 Clay Street, residence of Grace Lowe. We were shortly joined by two movers from H. & S. Warehouse. All four of us began a rapid preview of packing and storing to be done. The front door glass was partially broken out; the back door had been pried open. Pry marks were evident. Upon entrance we discovered the place had been ransacked. Ms. Lowe's belongings were scattered from hell to breakfast. Two guns were on the bed: a 410 shotgun and a 303 British rifle. The 410 shotgun was jammed with a 303 shell and the 303 rifle was fully loaded. Later in packing several boxes of ammunition for both : guns were discovered, as well as shells for a pistol not located in the residence. A large . . Magnavox console appeared undamaged by the breakin, as was a Panasonic TV. We obtained a camera and took pictures of the belongings; also obtained bolt cutters to gain entry to the two outbuildings, ... which also contained personal property. The locks were cut and new hasps and locks were placed on each building. Spotts, McLeod and Woodbury were joined for a brief period by Ken Powell and Barry Brown from Department of Highways, then by Mr. Bittner of the State Troopers. Surveillance continued through lunch and until 6:30 at night, when all buildings were locked and the front door of the residence was boarded up. We requested two more movers for the next day. Wednesday, April 16, Spotts, McLeod and Woodbury were joined by four movers at 9:00 a.m. Packing commenced and continued through lunch and finished approximately 4:00 p.m. At 10:00 a.m. John Irwin, Department of Highways Maintenance Section, came with a loader and cleared paths to the vehicles and the outbuildings, as requested. Approximately 2:00 p.m. Ken Powell and two wreckers from Motor Inn Towing arrived and removed the three vehicles to the Department of Highways' yard at 2301 Peger Road for storage. The moving company is not allowed to store items in aerosol cans, items that are perishable or which have broken seals, or are of a highly flammable or explosive nature. Therefore, several items were left in the buildings and between 10 and 15 gallons of homemade wine were poured out and the bottles stored.

Spotts and McLeod met with State Trooper Robert Woodbury and two movers from H & S Warehouse at 309 Clay street at 9:00 a.m. The glass in the front door had been broken and the lock on the rear door had been forced open. Trooper Woodbury entered first. The contents of dresser drawers had been strewn throughout the house. The drawers were hanging open. Boxes had been opened. bed had linens on it but had been slept in and not remade. Called Highways to bring a camera. Powell and Brown delivered camera. Woodbury took : : pictures. There were two rifles lying on the unmade bed with ammunition in them. Extra ammunition was found in the bedroom. There were plates of uneaten food in the refrigerator along with other perishables and opened jars and bottles (eggs, pickles, ketchup, etc.). There were dirty dishes in the sink and on the cabinets. It was obvious that the place had been ransacked but we had no . way of knowing whether anything was missing. two storage units were still locked. We opened them. H & S packed the majority of the items in the house this date. The parcel and movers were not left unattended at any time. Spotts and McLeod left in p.m. to get locks, etc. from the Department of Highways. Woodbury stayed at site. At end of day, house and storage sheds were secured for the night. HS called Mr. Hoque at H & S and requested four movers for following day.

4/16/75 Spotts called City Police to check on impounding of Grace Lowe's cars. Called Sgt. Hussey requesting trooper for this morning. McLeod and Sotts and Trooper Woodbury spent Day #2 watching the packing of Grace Lowe's belongings. Maintenance cleared paths for car removal and for clearing the sheds. Motor Inn Safety Lane came and pulled away the cars. Ray Mark stopped and giggled. He's moving Wike's foureplex. Man from M.U.S. stopped.

Spotts and McLeod met Trooper Woodbury and four movers from H & S Warehouse at 309 Clay Street. The buildings were opened and movers packed remainder They refused to pack opened perishable of items. items, explosive items such as gasoline, and gallon jugs of homemade wine. McLeod and Spotts emptied the wine into the snow and movers packed the jugs. We emptied perishable items from refrigerator left them on kitchen floor and movers packed refrigerator. We located and movers packed all yard items deemed packable. Undoubtedly, there are still items buried in the snow. Powell set up the removal of the car and two pickups which were

towed to storage at the Department of Highways. Upon completion of the move all buildings were resecured.

4/17/75 Called Sy. She's writing letter to M.U.S. re: removal of Grace Lowe's meter.

Grace Lowe in to see Tom Kouremetis.

7. Grace Lowe in - Powell spoke with her after Tom: Helped her to get the red Comet going. She is upset, naturally, and believes that the Department of Highways broke into her house. Grace had been in Monday for her stuff.

He was aware that Grace was in town and staying at the property, didn't know whether action would be necessary to remove her - said he would contact her attorney.

5/16/75 Jonny Brumbaugh from H & S called. Grace had been in earlier today for her belongings to be moved to Clay Street. They told her again nothing could be done without the Department of Highways' authorization. Also, if their file shows any memo and attachments from Ross to George Sheldon sometime prior to 11/19/74 requesting help and concurrence on the Grace Lowe situation. He will research and let us know.
- 3/24/78 Ruth Rogers, AG's office, called. There is some correspondence that might be pertinent to our files that occurred between Ross and George Sheldon. Told her I'd be over this afternoon to check it out.
- 3/28/78 Filing info on Grace Lowe that I obtained from the AG's files.
- 3/30/78 Called Gary Vancil with questions on the Grace

 Lowe cases we don't know for sure what's still

 open and what has been closed; he'll send us a

 memo regarding her status w/ us and w/ the courts.
- 4/3/78 Reading Grace Lowe's files uggh!

- 6/20/78 Phyllis called there are some interrogatories on Grace

 Lowe that she was to have given me last week. Went over

 and picked up a copy.
- 6/21/78 Showed Harold the latest action taken by Grace Lowe spent some time going through her folders to find answers.

 UGH.
- 6/22/78 Gary Vancil was in says Ross has written up some answers on the latest Grace Lowie goodie and would appreciate it if I would go over it with a critical eye.
- 6/23/78 Working on Grace Lowe.
- 6/26/78 Talked to Vancil about Grace Lowe Ross's list of answers has not arrived yet for me to look at. He says he found something that shows why Parcel 19A was created. Told him I would be over tomorrow for a copy. Told him that I could come up with 3 or 4 answers to each of her questions depending upon which way we wanted to look at the situation.
- 6/27/78 Called for: Gary he is doing depositions and won't be done until tomorrow.

- 6/28/78 Picked up copy of info from Gary regarding Grace Lowe.

 He would lifet a copy of a memo Tom wrote regarding filing of D/T on 19A.
- 6/30/78 Phyllis called Ross's interrogatory answers arrived.

 Went over to the AG's office and picked them up also gave
 Gary a copy of Tom's memo to Ross confirming condemnation

 of 19A. Gary is writing a short synposis of how 19A

 became a parcel.
- 7/13/78 Grace Lowe in directed her to Arnold's office. A bit later she came in to see me to confirm that it was the State that had the electricity to 309 Clay Street in April of 1975 even though "they" did not own it Confirmed that it was the State that directed MUS to cut off the power.
- 7/14/78 Gary Vancil called he has received some interrogatories

 from Grace Lowe that have to be answered by me regarding 30
 309 Clay Street.
- 7/18/78 Stopped by the AG's to pick up a copy of Grace Lowe's interrogatories. They said someone else had picked it up.

 Got back here no one has it. Called Gary. We will get a copy tomorrow.

7/19/78 Stuff from AG's office regarding Grace Lowe came via postal mail.

7/26/78 Dropped a copy of Grace's letter to the President off at Gary Vancil's office - he gave me a copy of Ross's answer's to her latest set of interrogatories from Grace.

8/16/78 Phyllis from the AG's called - Grace was in asking if my interrogatories were done. Phyllis told her I had completed them but the Ag's had to final them. Grace was satisfied. She asked about Helen - was horrified that she had died.

grace Low in - asked if I knew who took the "No Trespassing sign off the back of 307 Clay Street and who put the "State of Alaska" sign on . Told her I didn't know who took the No Tresspassing one off, but either Helen or I put the State of Alaska one on. She asked if Tom Kouremetis, Helen Sptts, or Ken Powell had been fired - told her no, they all left for personal reasons. She asked if Tom was going to be up here this fall - she had heard there were permafrost problems on the place he had sold. Told her I had not heard anything from him. But, then that was not unusual.

9/8/78 Saw Gary Vancil - he is filing some interogatories for Grace Lowe to answer.

Joe Schutz, FJWA, Portland called re: status of
Grace Lowe's case in District Court. Called
Satterberg, then Gary Vancil in Juneau - the case
was dismissed and Grace has filed an appeal in the
Circuit Court of Appeals in San Francisco. She
has 30 days from the filing of the appeal to turn
in a record of the proceedings resulting in the dismissal decision and a certain number of days after
that in which to prepare her brief and file a motion
indicating why she should recover relief. Then the
State will have a certain period of time in which
to reply.

Call Schutz and told him what I'd learned. He asked that I forward any copies of filings that I might receive. Called Gary back - he'll send me a copy of the appeal.

2/20/79 Sent copy of Grace LdWe's filings to Joe Schutz, FHWA.

4/11/79 Gary Vancil called. Gene Hanna has sent a memo to Bodine re: Grace Lowe's letter to the President and a Senator. He's sending me a copy and needs a seply. The memo is something to the effect that possibly Grace's buildings should have been determined living quarters and appraised and she should have been given relocation benefits. We shall see when the memo arrives.

- 12/21/79 Called Juneau A.G.'s office for either Bill Cummings or Jack McGee re: Grace Lowe. Spoke with a woman who answered the phone Billie Trent. She will send me a copy of our dismissal as well as Grace's and the State's briefs, which were filed after her appeal of our dismissal judgment.
