Pete, I haven't read this completely yet but it came after a phone call with Scott Ogan. A couple of years ago they started the process to assert an RS2477 on the Chitina Cemetary road which comes off of the Edgerton as it enters Chitina. I guess the battle is turning ugly and he has notified me that they believe there is a gate blockading the road and that it might be in the highway ROW. Recognizing that until they resolve the validity of the RS2477, if we notify the owner to remove the encroachment, they can always move it slightly outside the ROW and still keep people out. I told him we would pursue this by first contacting M&O to locate the road and measure the distance from the Edgerton centerline to the gate so we can see if it is an encroachment. If so, then we need to send out an encroachment removal letter. I know you are getting a lot of practice in Glennallen these days so this should go smoothly... Feel free to copy Scot Ogan directly once we get a response from M&O and also to let him know when we send out the encroachment letter if we find that it is in fact an encroachment. JohnB
