RS 2477 Research—Chena Hot Springs Area
Prepared by Charles L. Parr, SR/WA

Oversimplified, RS 2477 was a congressional provision allowing for the construction of roads over vacant, public (Federal), unreserved lands. RS 2477 was repealed in 1976.

George Wilson located and staked the major part of what is now the Chena Hot Springs Resort on May 16, 1908, and recorded his "Location Notice" May 28, 1908 in Volume 6 at Page 615 in the Fairbanks Recording District. The staking had the effect of segregating the land from the public domain so that the establishment of an RS 2477 right of way could not occur after that. There is no evidence of any such right of way being established before 1908.

When the property was surveyed as USS 1247 in 1916, a road is shown on the plat thereof as entering the west boundary of the property approximately 1356' south of the northwest corner at a location south of Monument Creek (field notes at page 202). The road is shown as continuing southeasterly approximately ¼ mile and terminating at a group of cabins.

When a portion of the property to the west was surveyed as USS 3129 in 1954, the entire west boundary of USS 1247 was retraced. The plat and field notes for USS 3129 show a "dozer trail" entering the west boundary of USS 1247 approximately 600 feet south of the northwest corner of USS 1247 which is north of Monument Creek and about where Chena Hot Springs Road is today. Neither the plat nor field notes reference the road shown on the USS 1247 plat.

When a portion of the property to the east was surveyed as USS 4228 in 1964, the entire east boundary of USS 1247 was retraced. The plat and field notes for USS 4228 show a runway in the approximate location of the existing runway, but make no reference to any road "exiting" USS 1247. An "unimproved" access road is shown and referenced as crossing the east boundary of USS 4228, but there is no reference as to where it begins or where it goes. That access road is also shown on the plat of USS 4146 (also surveyed in 1964) which is contiguous with USS 4228. Again, no additional information is provided in the field notes. A "tractor trail" is shown crossing the northerly boundary of USS 4146 and mentioned in the field notes without additional information.

Right of way drawings prepared by the Department of Highways in February 1967 for the "Chena Hot Springs Road Mile 55 to Chena Hot Springs" project were for the present alignment of Chena Hot Springs Road, and terminated the right of way within USS 1247 just before the Monument Creek Bridge. The Department eventually acquired that portion within USS 1247 in 1971 by initiating the condemnation process and being granted a "Declaration of Taking". Monument Creek is shown on the right of way drawings and court related documents, but no reference is made to a road or trail south of Monument Creek as indicated by USS 1247.

Access to the state mining claims along Monument Creek may exist by means other than RS 2477 (e.g., section line easements, prescription, permission, estoppel, etc.). The first state claims that were located in the entire township (T3N, R9E) were in 1981 and 1983, and all of them have been closed since. The currently active claims on Monument Creek were located in 2003 and 2005. No record of federal claims on Monument Creek located prior to State ownership was found.




RIGHT OF WAY

KEY MAP PROJECT NO. S-0650(13)



DECLARATION OF TAKING

I, the undersigned, Charles S. Matlock, Deputy Commissioner of Highways of the State of Alaska, on behalf of said State, do hereby make the following declaration:

I.

(a) The property hereinafter described is taken under the authority of and in accordance with AS 19.05, AS 19.10, AS 19.20, and AS 09.55, which authorize the acquisition of property by the Department of Highways, State of Alaska, deemed necessary for the public use of the State of Alaska.

(b) The public use for which it is necessary to take the property is for the right of way for a Federal Aid Highway designated as Alaska Project No. S-0650(13), CHENA HOT SPRINGS ROAD, MILE 55 TO CHENA HOT SPRINGS. This highway will form a part of the State secondary highway system. The property hereinafter described is deemed necessary by the undersigned for said public use of the State of Alaska.




