Hi Tim,

There is, but we in the Survey Section believe it to be incorrect, are not currently using it, and are waiting on a revised/corrected & signed copy. For an unknown reason it cites the date of AS 19.10.015 (footnote 2) to use to determine width.

AS 19.10.015 determines highway widths, AS 19.10.010 determines section-line easement widths. The drafter's reasoning is beyond me.

For the record, the Survey Section was involved at the very beginning phases of this document (in early 2020), unfortunately our comments were not paid attention to; and the 12/30/2020 document was approved without the Survey Section seeing it so we could give it our final okay.

I'm under the understanding the signers were informed a long time ago about this, but as of today I have not heard anything, or even been asked any questions.
