Troy Hicks contacted Gwen this week re the redlined MHT/DNR/DOT SLE Agreement provided by DNR. Troy, Gwen, George Horton, Stan Brown and I had an MS Teams meeting to discuss. We all agree the memo should be corrected to reference the proper statutes and set policy on proper purpose etc. George is to submit a second red-lined version of the current signed agreement to DOT&PF Northern Region in two weeks after a more exhaustive review by him. George sent Troy and me the 1963 Legislative Council letter you found supporting our position. Troy and I met with Barry Hooper. I provided Barry with the 1963 letter. Barry read the 1963 letter and the current redlined version of the signed MHT/DNR/DOT SLE Agreement provided by DNR. Per conversation with Barry I think he has a pretty good grasp of the issues. Barry is in agreement to push this up the chain once we have the second red-lined version of the MHT/DNR/DOT SLE Agreement. I think your involvement in this process would help a great deal.
